

Vice President of Development

United Way of Pierce County in Tacoma, WA has embarked on a search for a talented, creative leader who has the leadership, relationship, and development skills to be its next Vice President of Development.

United Way, along with its community partners, has forged a bold path to lift 15,000 households out of poverty and into financial stability by 2028, one family at a time. At this time, more than 6,300 households have are moving toward self-sufficiency and on their way to building wealth. As a catalyst for change, we bring people together to convene around public problem solving that focuses on the continuum of moving families out of poverty. Getting people out of poverty isn't a linear path. To create lasting impact, we take an integrated approach:

A Strong Foundation of Basic Needs: By ensuring basic needs such as food, clothing, transportation, health and shelter are met families can move out of crisis and into stability.

Breaking Down Barriers: Navigating supportive services like affordable childcare, English language skills, technology, legal assistance, and safety needs provide greater family stability.

Financial Stability: Employment placement, financial coaching, education and workplace skills move families from stable to thriving.

Creative solutions to community problems require innovative approaches to solving the complex issue of poverty. All the resources raised are invested in our poverty-fighting work and community partners that are aligned with our mission to address the barriers of poverty and move more families to self-sufficiency.

Leading a staff of eight, the VP will be responsible for all the development activities of United Way to strategically diversify revenue, including major gifts and Alexis de Tocqueville Society, grants, sponsorships, planned gifts via Legacy Society, direct mail, special events, corporate gifts and volunteering. This includes the traditional annual campaign and other fundraising and engagement activities, which generates approximately \$5 million. In addition, the once-in-a-lifetime milestone Centennial Campaign, is coming to a close in December 2023, and has raised \$6.8 million to date and 26 planned gifts.

The position offers great professional and personal satisfaction through its high profile work with a wide range of top community leaders from the corporate, nonprofit, government, education, business, philanthropic and organized labor sectors of Pierce County.

COMMITTED TO LIFTING 15,000 HOUSEHOLDS OUT OF POVERTY AND FAMILY AT A TIME INTO FINANCIAL STABILITY BY 2028, ONE FAMILY AT A TIME

Today in Pierce County, one in three local households have incomes above the federal poverty level, but below the cost-of-living threshold. While employment has been on the rise, more than half of newly hired workers earn less than what they need for their families. These families are ALICE (Asset Limited, Income Constrained and Employed). They are often working more than one job and still can't make ends meet.

As a community convener, we work across sectors to make the meaningful changes that are needed to fight poverty. This need is also the driving force behind our annual From Poverty to Possibilities summit where we work together, as a community, to uncover key challenges facing families. This year's summit highlighted the cliff effect (families losing their public benefits before they are ready to be self-sufficient), the need for more training and higher participation in changing public policy and the need to address systematic barriers.

Everyone should have the opportunity to achieve a sound standard of living with the dignity that comes from being engaged in and respected by their community. Three key conditions guide our work: economic success, autonomy and being valued in the community

The transformation that occurs from our work is far greater than what a small group in the community or an organization can achieve alone. Thanks to the community's generosity, in 2022 we improved conditions for 144,708 people in Pierce County through our direct network of partners, programs and services. In addition, we helped people gain stability and greater financial self-sufficiency.

The VP oversees all fundraising efforts including workplace campaign, corporate giving, and foundations and works collaboratively with the Vice President of Community Impact to achieve organizational and revenue goals. The VP will work closely with United Way's marketing consultant to implement the organization's strategic communications.


